ANTI RAGGING CELL

As per the Karnataka Educational Act 1983 and the directive of Honorable Supreme court of India, Besant Evening College ensures Strict compliances on the prevention of Ragging in any form on its campus. Ragging is a criminal offence which can destroy a student physically and emotionally.

Ragging means teasing, embarrassing and humiliating; Assaulting or using criminal force or intimidation; wrongfully restraining or confining or causing hurt; causing grievous hurt, Kidnapping or committing unusual offence; causing death or abetting suicide . It also means display of noisy, disorderly conduct, doing any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear or shame or embarrassment to a student whether he/she is a junior or fellow classmate and includes-

Teasing, abusing of, playing practical jokes on, or causing hurt to such student or asking the student to do any act or perform something which such student will not, in ordinary course do, willingly.

Composition: The Committee shall be constituted from time to time. It shall have-

1. Principal as Chairman.
2. One/two faculty members.

Functions:

- ❖ To uphold and comply with the directions of the Hon'ble Supreme Court and be vigilant on any acts amounting to ragging.
- ❖ To publicize to all students and prevalent directives and the actions that can be taken against those indulging in ragging.
- ❖ To consider the complaints received from the students and conduct enquiry along with punishment recommended for the offenders.
- ❖ Oversee the procedure of obtaining undertaking from the students in accordance with the provisions.
- ❖ Conduct workshops against ragging menace and orient the students.
- ❖ To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls.
- ❖ To offer services of counseling and create awareness to the students.
- ❖ To take all necessary measures for prevention of Ragging inside the Campus.

Punishment: Higher Educational Institutions, 2009, depending on the nature and gravity of the guilt established by the Anti Ragging Squad, those found guilty may be awarded one or more of the following punishments-

- Warning , writing apology letter
- Suspension from attending classes and academic privileges.
- Withholding/ withdrawing scholarship/ fellowship and other benefits.
- Debarring from appearing in any test/ examination or Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/ expulsion from the hostel.
- Cancellation of admission.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
